The International Community of Women of living with HIV Eastern Africa (ICWEA) is seeking to recruit One (1) Advocacy and Communications Officer who will be stationed at ICWEA's Offices in Wakiso District.

Background: The International Community of Women living with HIV Eastern Africa (ICWEA) together with HEPS Uganda and Sexual Minorities Uganda (SMUG) has received funding from President's Emergency Plan for AIDS Relief (PEPFAR) Uganda to scale up the Community Led Monitoring (CLM) Project in Uganda through Country Operational Plan (COP) 2020/2021.

Community-led monitoring is an approach to assessing the quality of health services (HIV/TB services). It is initiated and implemented by networks and organisations of people living with HIV, key populations and other priority affected populations. It involves use of a structured tool with a set of questions for gathering quantitative and qualitative data and observations about components of HIV/TB and other related services. The aim is getting input from recipients of these services on quality, accessibility and availability. The data generated is then used by service recipients and other advocates (PLHIV, key populations, CSO, CBOs) to design community actions for change in the status of HIV/TB and other related services.

The Advocacy and Communications Officer will be responsible for providing strategic and operational oversight of the CLM's advocacy, communications, and campaign activities. The Advocacy and communication officer is responsible for CLM's strategic advocacy and campaign goals including developing and managing a CLM Advocacy Agenda and ensuring that CLM is integrated into policy and funding priorities. The Advocacy and Communication Officer will also manage any communications and public relations activities and publications related to CLM.

Qualifications

The applicant should hold a Bachelor's Degree in Mass Communication, Journalism, Development Studies, Law, Social Work or Social Sciences /Arts with Literature in English/English Language Studies as subjects; obtained from a recognized University/ institution.

Key responsibilities

- 1. Develop and implement strategic actions for agreed advocacy objectives;
- 2. Support districts and regional teams to develop and implement advocacy and communication plans;
- 3. Work with all relevant and diverse partners to foster and build support for relevant advocacy aims
- 4. Build partnerships and coordinate work with other networks and allies in the HIV/TB response and beyond to maximise the chance of securing advocacy wins;
- 5. Develop and maintain clear lines of communication with advocates and key stakeholders and use this to inform work within CLM
- 6. Develop policy briefs and position papers and other useful resources in relation to the CLM advocacy objectives;
- 7. Support the Project Coordinator in developing and implementation of CLM advocacy strategy;
- 8. Work with the PLHIV and KP networks at national and sub-national levels, community monitors and regional coordinators to maximise their engagement in CLM advocacy and communication activities and campaigns;
- 9. Generate CLM specific social media and website content

- 3. Proven experience of working with members of a network and knowledge of how it is different to working in one single organisation
- 4. Experience of effectively using the media to build awareness around campaigns
- 5. Understanding of human rights and people centered approaches
- 6. Experience in advocacy

- Proven ability to develop and implement advocacy strategies
